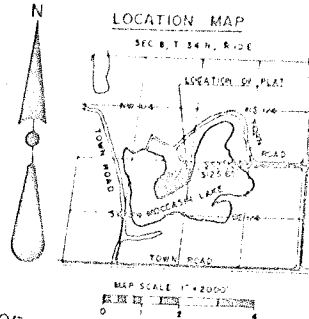


# BLACK'S MOCCASIN LAKE

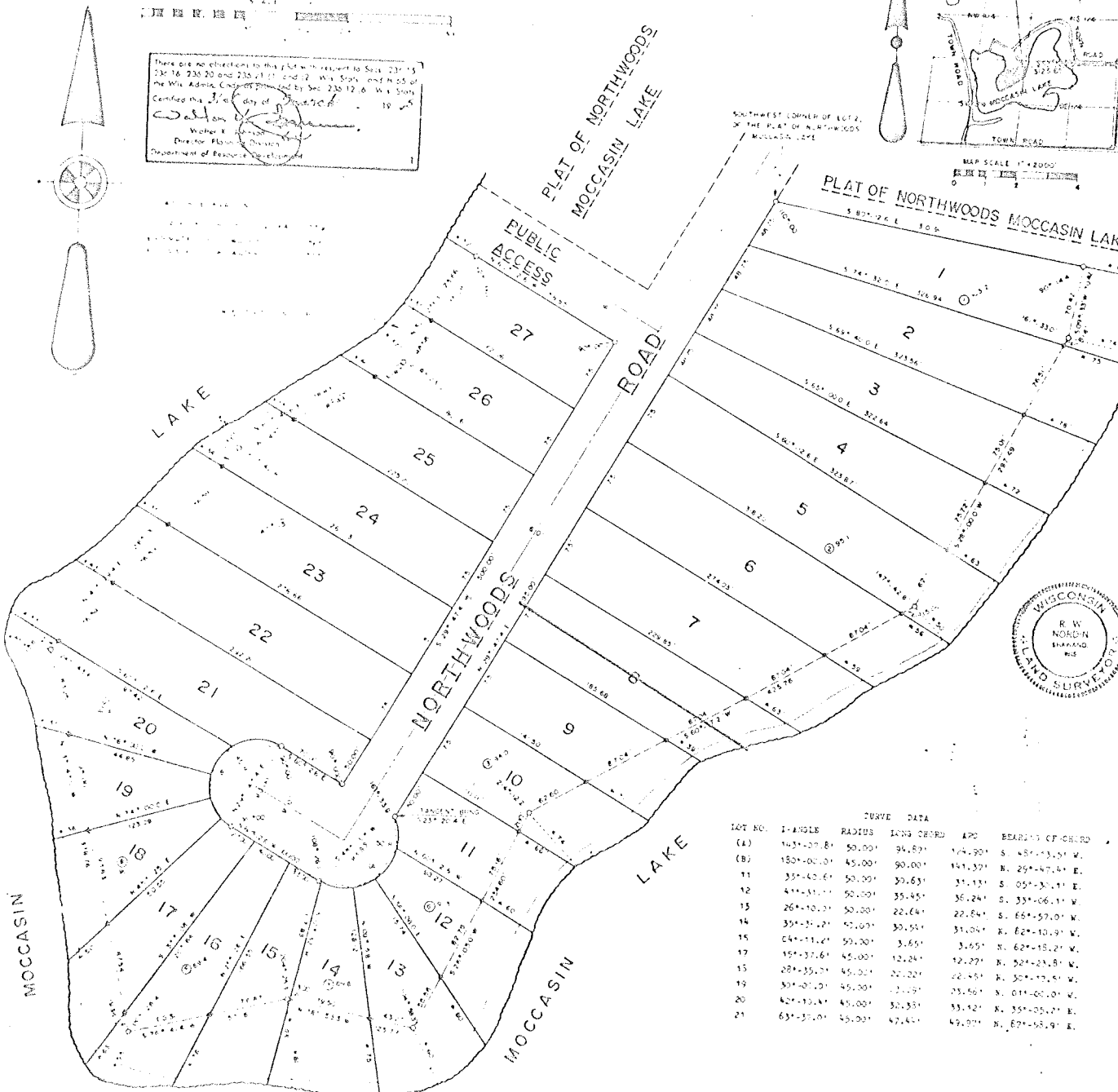

O Indicates 2" x 30" Iron Pipe weighing 1.65 lbs. per lin. ft.  
● Indicates 1" x 30" Iron Pipe weighing 1.15 lbs. per lin. ft.  
All distances are measured to the nearest hundredth of a foot.  
Benchmark is top of 2" x 30" Iron Pipe marking center of Section 8, Township 34 North, Range 10 East, also being the intersection of the center line and the north line of Lot 1, Plat of Northwoods Moccasin Lake; Elevation 430.00.  
Indicates location of test boring and pipe location test; number within circle denotes number of feet elevation given in ground elevation at test hole.  
All bearings and angles are to the nearest tenth of a minute of arc.  
ALL OTHER LOT CORNERS ARE MONUMENTED WITH 1/2" x 30" IRON PIPE, MIN. WT. 1.15 LBS./FT.
