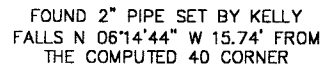

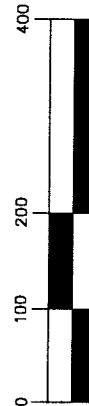

LANGLADE COUNTY PLAT OF SURVEY

a line being part of the Southwest 1/4 of the Northeast 1/4 of Section 3, Township 33 North, Range 12 East, Town of Ainsworth, Langlade County, Wisconsin more particularly described as follows:

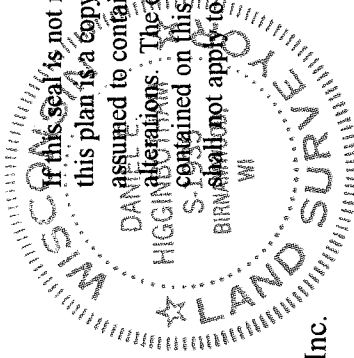
Commencing at the North 1/4 corner of Section 3; thence S 03° 49' 20" E, 1829.51 feet to an iron pipe set by William Kelly as shown on Map No. 30255 as filed in the Langlade County Surveyors Office; thence N 89° 36' 47" E, 24.17 feet along the South line of the 11.3 Acre parcel as shown on Map No. 30255 to the Easterly R/W of County Road T and the point of beginning of the line herein described; thence continuing N 89° 36' 47" E, 1291.13 feet along said South line to the East line of said 11.3 Acre parcel; thence N 03° 50' 44" W, 557.04 feet along the East line of said 11.3 Acre parcel to the North line of the South 1/2 of the Northeast 1/4 of Section 3 and the termination of the line herein described.

Subject to all roadways and easements of record.

This description is written for purpose of defining the South and East lines of the 11.3 Acre parcel as shown on Map No. 30255 filed in the Langlade County Surveyor's Office. I believe the intent of this survey was to better define a parcel of land that was sold from the Boy Scouts to Charles Gravitter Sr. in Document No. 286917 Langlade County Records. The Bearings and Distances found on this survey were then used to write the description found in Document No. 289380 Langlade County Records which is a Quit Claim Deed transferring interest to Aderholdt.
