SURVEYOR'S CERTIFICATE

State of Wisconsin, }
County of Langlade, } s.s. I, Alex Deleglise, surveyor, do hereby certify that by order and direction of Chas. H. Thompson and in full compliance with C. 101 of the revised statutes of 1918, I have surveyed and mapped Government Lot Six (6) and a part of Lot Five (5) of Section Eleven (11) of Township Thirty-four (34) North, of Range Eleven (11) East, Langlade County, Wisconsin, described as follows:- Commencing at the center of said section, thence North on quarter line about 189 feet to the shore line of Post Lake; thence Westerly and Southerly along the shore line of said lake to the center of the East end of the steel truss bridge over said lake; running thence S. 60° 06' E., 197.8 feet to a 2" X 24" iron, thence S. 86° 23' E., 273.7 feet to a 2" X 24" iron, thence N. 80° 58' E., 990 feet to the South-east corner of Gov't Lot 6, at which corner there is a 2" X 24" iron; thence North on the one-quarter line 1395.81 feet to the center of the section, being the place of beginning; excepting therefrom one acre of land in the Southeast corner of Gov't Lot 6, here-to-fore conveyed for school purposes. The North and South quarter (1/4) line I assumed to be the true meridian. I placed the center of the section at the intersection of a true line between the E. and W. quarter (1/4) posts, and a line running N. from the South quarter (1/4) post immediately between the E. and W. section lines. All angles were read to the closest minute by a transit. That the accompanying map together with the figures and notes thereon is a true and correct representation of the land above described and the subdivisions therein made. 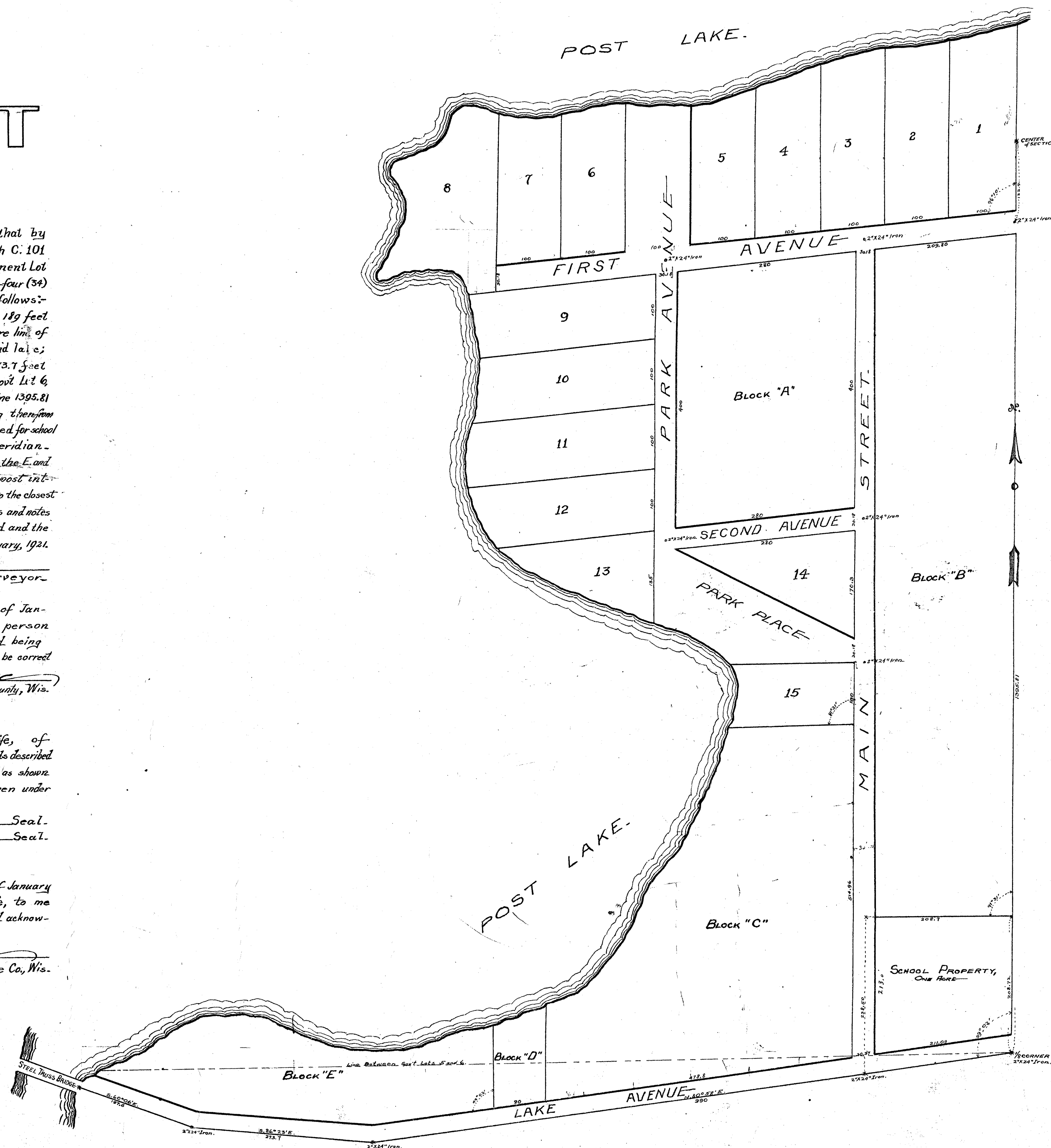
