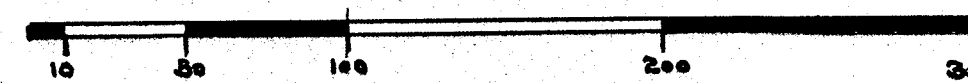


LAURSEN ADDITION
