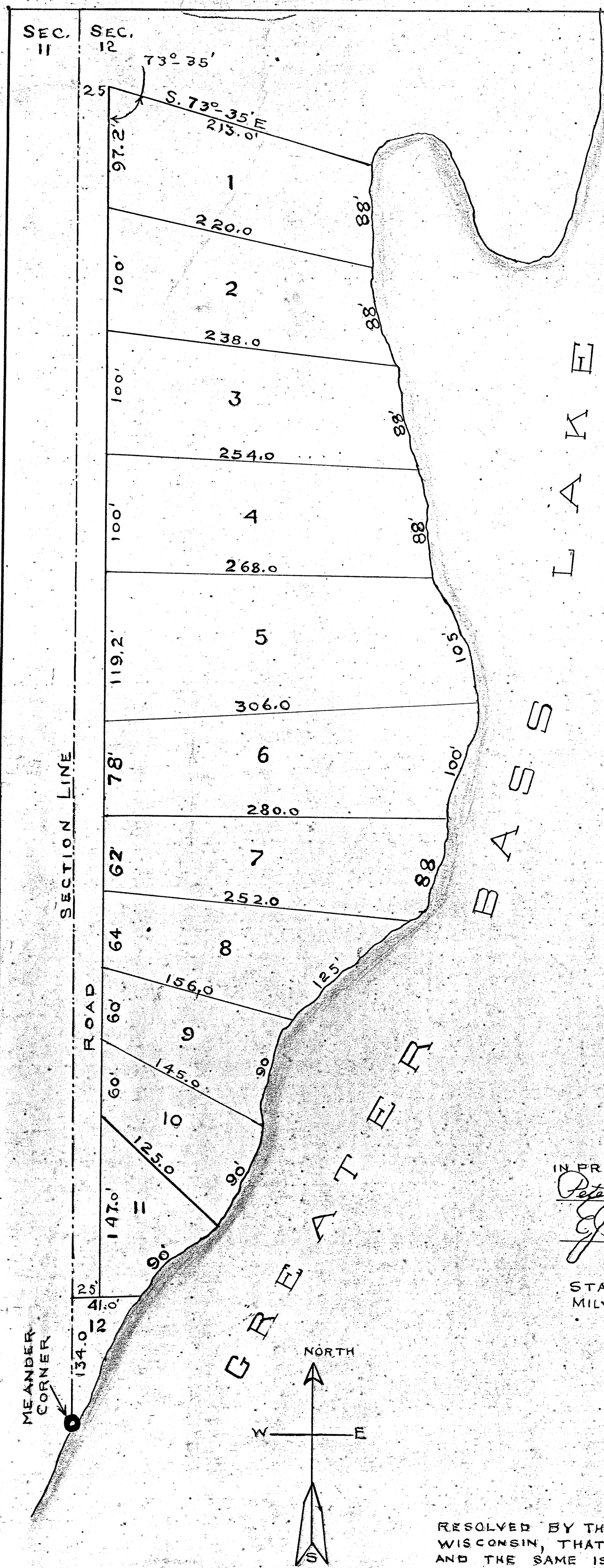




SURVEYORS CERTIFICATE

I HEREBY CERTIFY THAT I HAVE, WITHIN THE LAST THIRTY DAYS, SURVEYED, SUBDIVIDED AND PLATTED THE LAND REPRESENTED BY THIS MAP, BY DIRECTION OF ROBERT C. FREIHUBE AND GERHARDT H. FREIHUBE, THE OWNERS OF SAID LAND, THAT SAID MAP IS A CORRECT REPRESENTATION OF ALL BOUNDARIES OF LAND SURVEYED AND SUBDIVIDED, AND THAT IN SURVEYING, SUBDIVIDING AND PLATTING THE SAME I HAVE FULLY COMPLIED WITH CHAPTER 236 OF THE REVISED STATUTES OF THE STATE OF WISCONSIN FOR THE YEAR 1923 AND ALL ACTS AMMENDATORY THEREOF AND SUPPLEMENTAL THERETO. THE LANDS ENCLOSED IN THIS MAP ARE DESCRIBED AS A PART OF GOV'T LOT 6 SEC. 12 T. 33 N. R. 10 E. AS FOLLOWS:- COMMENCING AT THE MEANDER CORNER ON THE SHORE OF GREATER BASS LAKE, THENCE NORTH ON THE SECTION LINE BETWEEN SECTIONS 11 AND 12, 1124.0 FEET, THENCE S. 73° 35' E. 213.0 FEET TO THE SHORE OF GREATER BASS LAKE, THENCE SOUTHERLY AND WESTERLY ALONG THE SHORE OF GREATER BASS LAKE TO PLACE OF BEGINNING. THIS PLAT IS A SUBDIVISION OF FREIHUBE'S FRONTAGE. THE FIGURES IN THE CENTER OF THE LOTS ARE THE NUMBERS OF THE SAME. THE LENGTH AND WIDTH ARE REPRESENTED BY FIGURES ON THE MARGIN THEREOF
