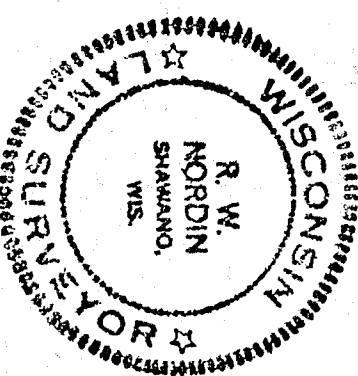

There is hereby reserved to the Town of Elcho for future
public street or road purposes an additional 3 feet of right of
way from each abutting lot parallel and contiguous with all streets
having a width of less than 66 feet, in order to establish uniform
street widths of 66 feet in accordance with minimum street width
requirements per sections 86.26 and 236.16 (2), Wis. Stats.
