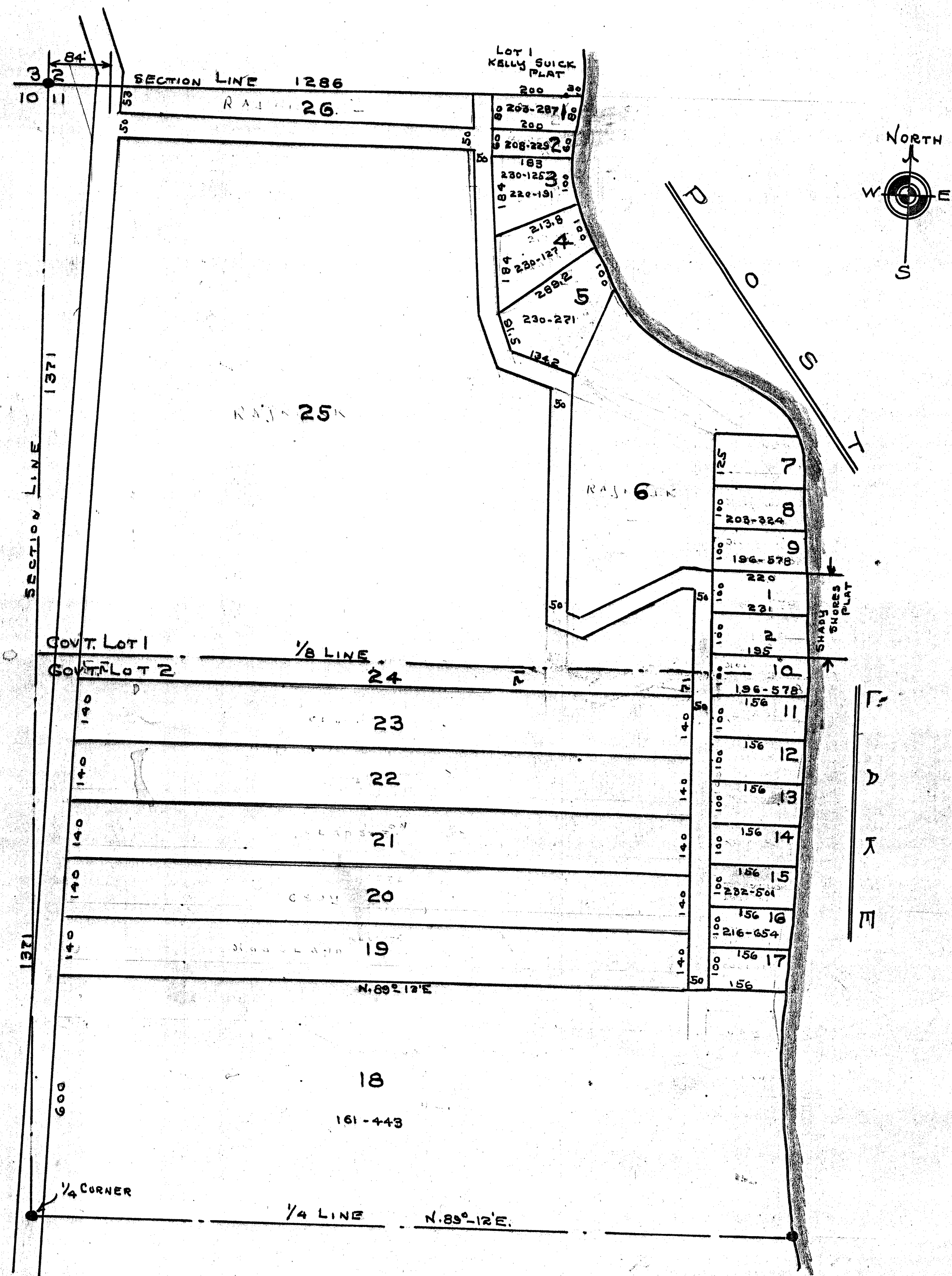


ASSESSORS PLAT
