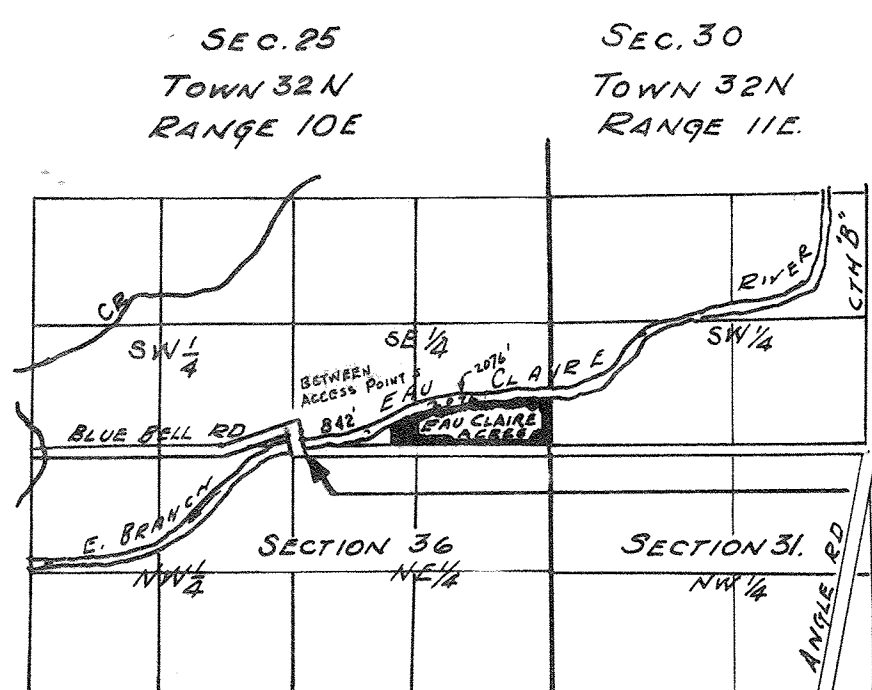

SCALE 1"=2000'



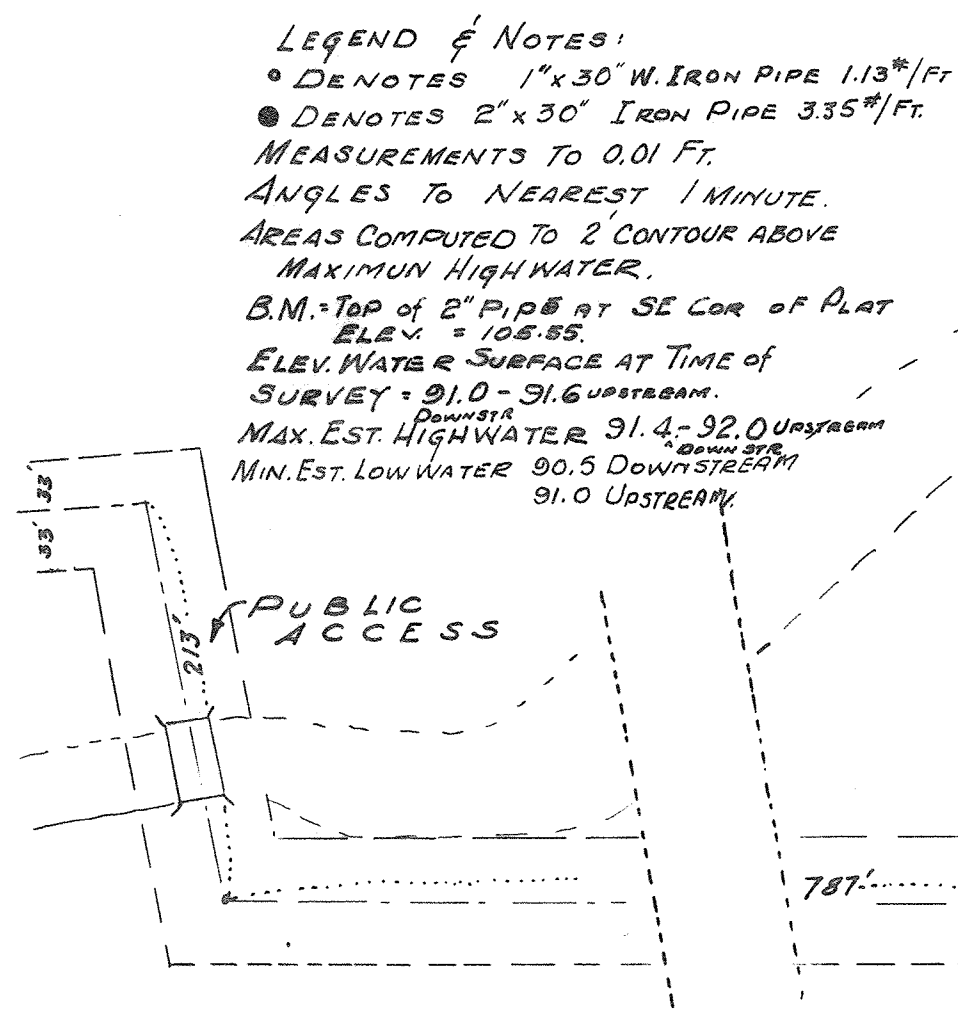

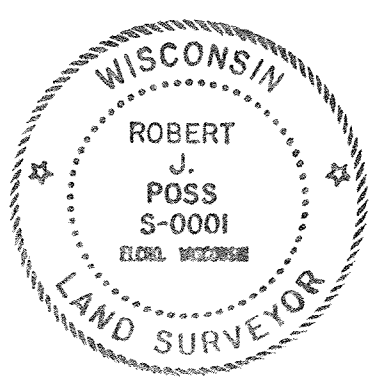
