ALONG THE NORTH LINE OF THE HIGHWAY 167.6 FEET, THENCE N. 39° 45' E. 421.8 FEET TO SHORE OF POST LAKE, THENCE NORTHWESTERLY, NORTHERLY AND NORTHEASTERLY, ALONG THE SHORE OF POST LAKE TO PLACE OF BEGINNING.
