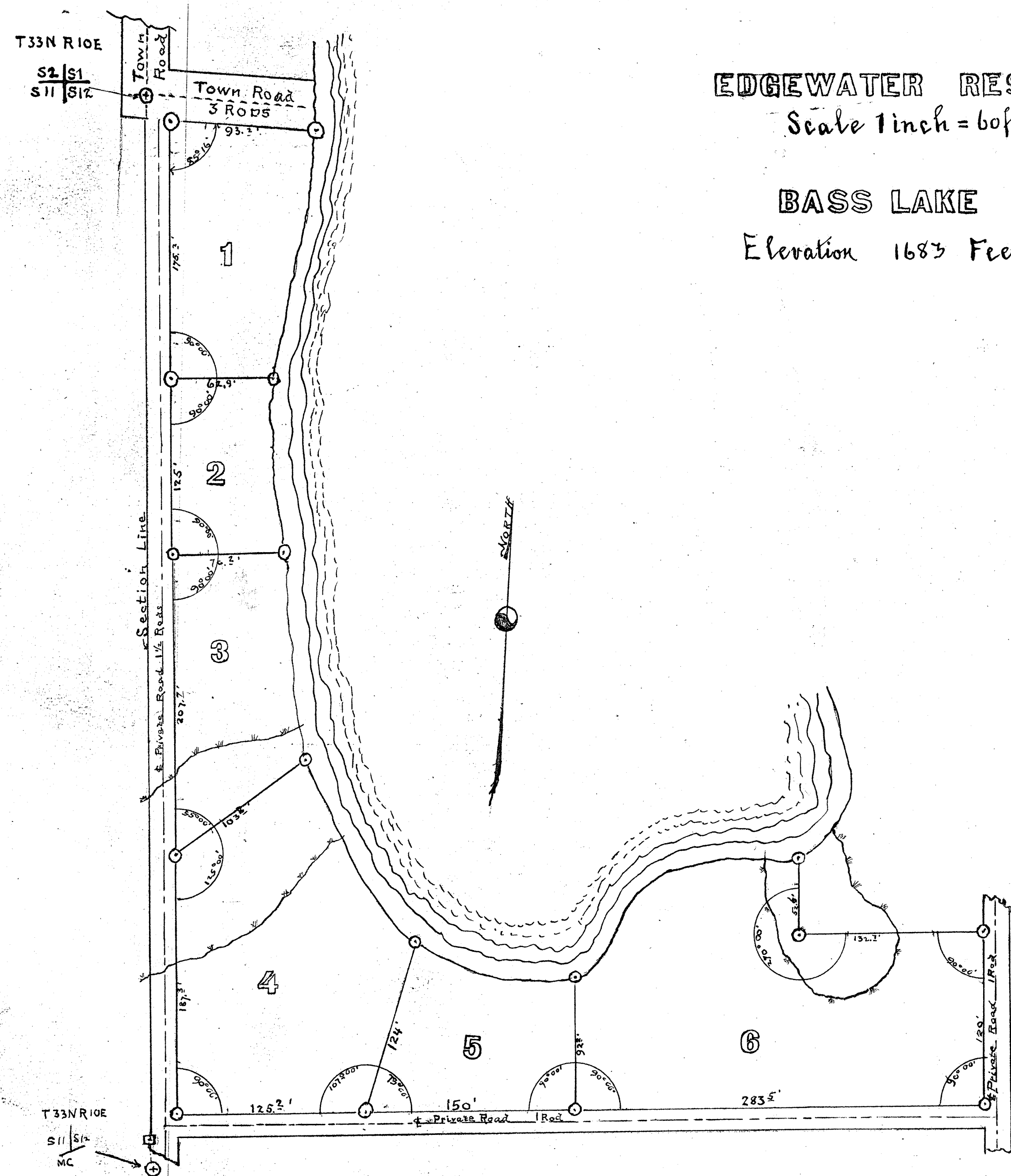




EDGEWATER REST

R. 10 E., described as follows: Commencing at a point 24.2 ft. South of the S.C. between Sections 12 and 11 & 12, T. 33 N. R. 10 E., thence South 71.7 ft. on line between said corner and M.C. between Sections 11 & 12; thence East (angle 90°-00') 608.2 ft.; thence North (angle 90°-00') 136.5 ft.; thence West (angle 90°-00') 149.3 ft.; thence North (angle 90°-00') 52.4 ft. to Bass Lake (H.W.M.); thence West and N.W. to a point South 85°-44' East of the point of beginning (H.W.M.); thence West 18 ft. to the point of beginning (In Lot Six (6), Govt).
