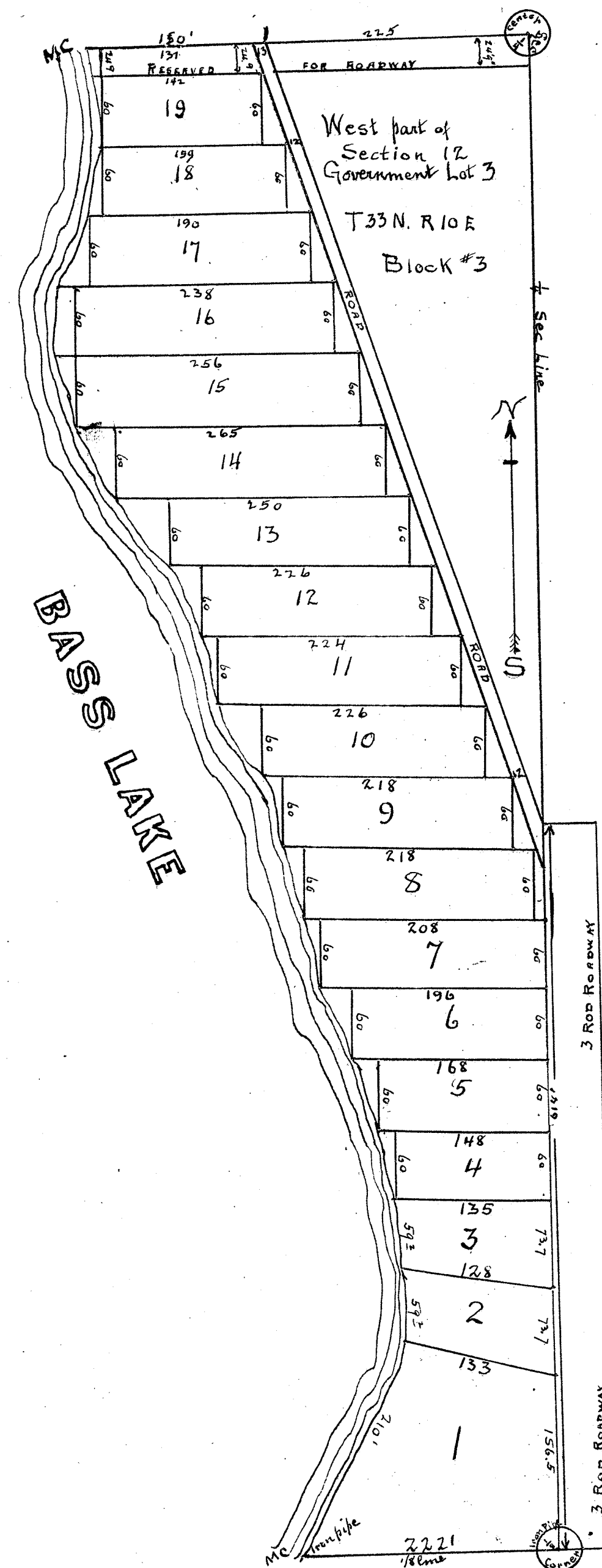

We, David B. Edick and James H. Edick of the City of Antigo, County of Langlade, State of Wisconsin, do hereby certify that in month of July A.D. 1923 by the order of the Langlade Lumber Company a Wisconsin corporation, with its principal office in the said City of Antigo we surveyed and platted the First Addition to the Original Plat of Langlade Beach, the same being a subdivision of Government Lot Three (3) Section Twelve (12) Township Thirty three (33) North of Range Ten (10) East of the Fourth (4th) Principal Meridian. This subdivision comprising Lots One (1) to Nineteen (19) inclusive of Block Three (3). Beginning at a point on North and South one quarter line at South Boundary of Lot Three (3), Thence North along one quarter line, six hundred fourteen feet to a point, Thence North 22° West seven hundred seven (707) feet to a point on East and West one quarter line, Two hundred twenty five feet (225') West of center of section, Thence West along said one quarter line One hundred Fifty feet (150') to Meander corner on Lake shore Thence in a South easterly direction along Lake shore to Meander corner between Government Lots Three (3) and Four (4), Thence East Two hundred and twenty two (222) feet along line between Lots Three (3) and Four (4) to place of beginning, said subdivision being a part of Government Lot Three (3) Section Twelve (12). That we have placed iron pipes at the South East and South West corners of Lot one (1) Block Three (3). That the annexed plat is a true and correct map of such survey and the subdivision thereof made. That we have fully complied with all the provisions of Chapter 101 of the Revised Statutes of the State of Wisconsin in surveying and mapping the same.
