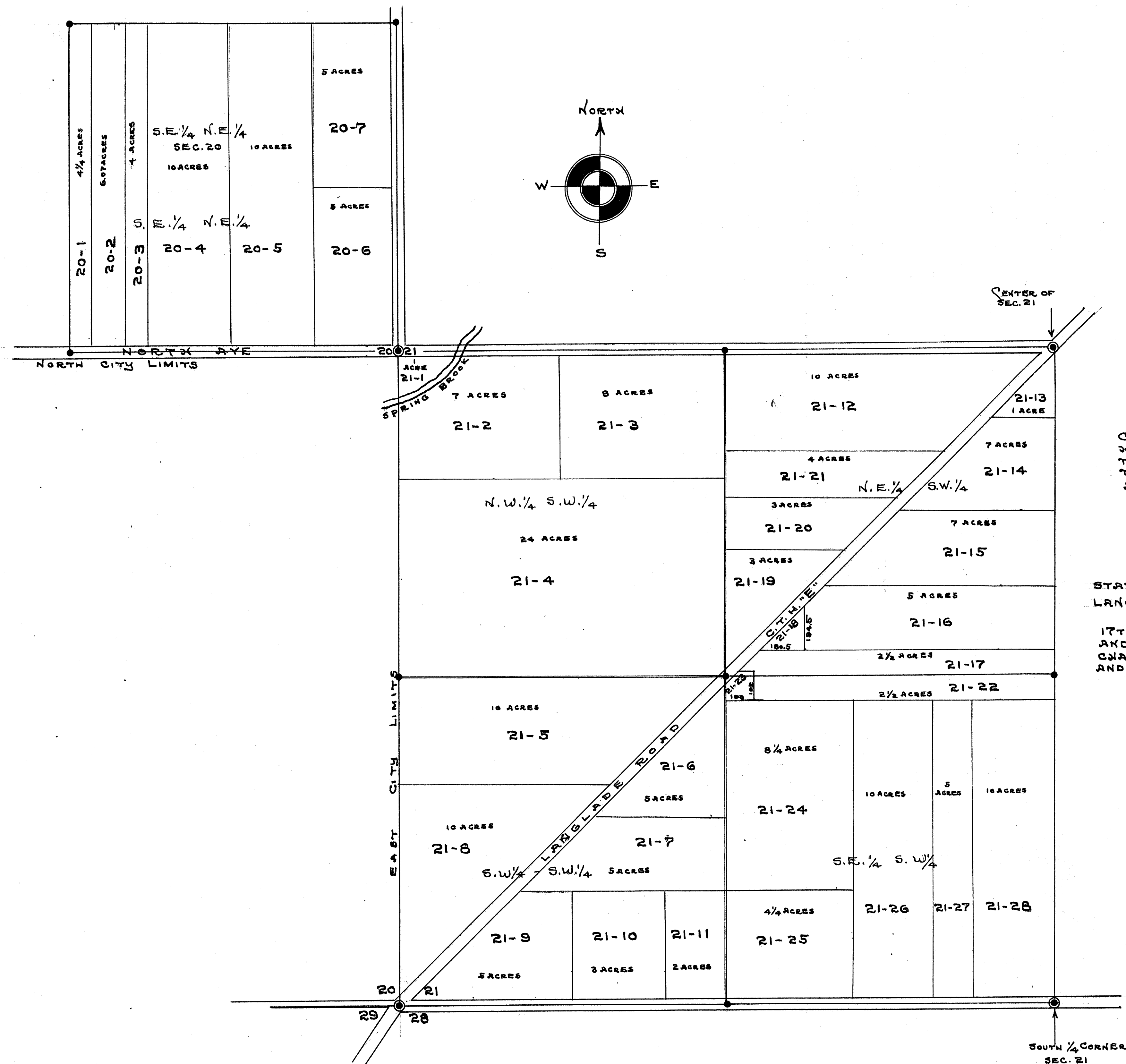


ASSESSOR'S PLAT OF S.E. 1/4 N.E. 1/4 SEC. 20 - S.W. 1/4 SEC. 21
